**1. PARTIES**

The User (also hereinafter referred to as "you") named in this application and agreement ("Agreement") hereby contracts with The Global Name Registry Limited for a non-exclusive, non-transferable, limited right to obtain and use a persistent password (the "Password") to access the .name WHOIS Extensive search database and to search and use personally identifiable information about a .name registrant contained therein (the "Data") under the terms and subject to the limitations of this Agreement. Upon execution of this Agreement by Global Name Registry, we will return a copy of this Agreement with your UserID and Password.

**3. PURPOSE**

By signing this Agreement, you certify that you and the additional Authorized Individual Users listed on Attachment 1 hereto, which is incorporated by reference

herein, will access and use the Data solely for the purpose(s) you specify below (check all that apply):

#### **4. TERM**

This Agreement is effective for a period of twelve (12) months from the date of execution by Global Name Registry (the "Initial Term"). Global Name Registry will send an e-mail to the address listed in Section 2(h) above notifying you at least seven (7) days prior to the expiration of the Initial term. If you re-certify the purposes for which you agree to use the Data and your compliance with the terms and conditions of this Agreement, as it may be amended, Global Name Registry will renew the Agreement for a successive twelve-month renewal term (a "Renewal Term"; the Initial Term and any successive Renewal Term together make up the "Term"). The Term shall continue until its expiration or until this Agreement is terminated by either party as set forth in Section 12 below.

#### **5. GRANT OF ACCESS AND USE**

Global Name Registry grants to you and to the additional Authorized Individual Users, a non-exclusive, non-transferable, limited right to use an assigned Password to access and use the Data exclusively for the purpose(s) described in Section 2 and otherwise in accordance with this Agreement. Global Name Registry may change your password on a bi-monthly basis by providing seven (7) days advance notice via e-mail to the address listed in Section 2(h) above.

#### **6. CONDITIONS OF ACCESS AND USE**

You agree that you and all Authorized Individual Users will:

- (a) access and use this Data only for the specific purposes set forth in Section 2 of this Agreement;
- (b) use the Password only to access and use the Data in accordance with the terms and conditions set forth in this Agreement;
- (c) under no circumstances access or use this Data to: (1) allow, enable, or otherwise support the transmission of commercial advertising or solicitations (not including good faith offers to resolve disputes through entering into a license agreement or otherwise) to entities or individuals whether by e-mail, postal mail, telephone, facsimile or other methods of communication; or (2) enable high volume, automated, electronic processes that send queries or data to the systems of Global Name Registry or any registrar accredited by the Internet Corporation for Assigned Names and Numbers ("ICANN"). Global Name Registry reserves the right, following ICANN's approval of a modification to the then-current Registry Agreement by and between Global Name Registry and ICANN ("ICANN Approval"), to specify additional specific categories of prohibited uses or to establish additional limitations on access to and use of the Data by giving you reasonable notice delivered via e-mail to the address listed in Section 2(h) above at any time. Upon your receipt of such notice, neither you nor your Authorized Individual Users may make such prohibited use of the Data or violate the new terms and conditions. Global Name Registry may, with ICANN Approval, prevent you and your Authorized Individual Users from accessing the Data until you have indicated your agreement to such additional prohibitions, terms, and conditions.
- (d) copy the Data (or any portion or copy thereof) into a machine-readable or printed form only as necessary to use it in accordance with this Agreement;
- (e) not share or otherwise distribute the Password to any individual or entity that is not bound by this Agreement;
- (f) except as necessary to accomplish the purpose set forth in Section 3 above, not distribute the Data (or any portion or copy thereof) to any other party without the express prior written consent of Global Name Registry; and
- (g) take all reasonable steps to protect against unauthorized access to, use of, and disclosure of the Data and the Password.

## **7. FEE**

At this time Global Name Registry requires no fee for use of the Password or the right to access and use the Data. Global Name Registry reserves the right to assess or

impose a fee for such access and use, with ICANN Approval, on thirty days prior notice.

## **8. PROPRIETARY RIGHTS**

You agree that no ownership rights in the Password or the Data are transferred to you or your Authorized Individual Users under this Agreement. You agree that any copies of the Data that you or your Authorized Individual Users make will contain the notice and disclaimer that appears in Attachment 2 to this Agreement.

## **9. METHOD OF ACCESS**

Global Name Registry reserves the right, with ICANN Approval, to change the method of access to the Data at any time, including the granting of Passwords under this Agreement. You agree that, in the event of significant degradation of system processing or other emergency, Global Name Registry may, in its sole discretion and without notice, temporarily suspend access under this Agreement in order to minimize threats to the operational stability and security of the Internet, the Global Name Registry servers, the .name registry, and the database containing the Data.

## **10. VIOLATION**

You agree that you are liable to Global Name Registry for any costs, liabilities, losses, fines, or expenses (including attorneys' fees) arising in connection with any claim, lawsuit, action, proceeding or regulatory enforcement action brought by any third party against Global Name Registry, howsoever arising, as a result of acts or omissions by (a) you or any Authorized Individual User constituting violation of your obligations to Global Name Registry under this Agreement or (b) any other individual or entity to whom you or an Authorized Individual User have provided the Password, the Data, or copies of the Data that would, if performed by you, constitute a violation of your obligations to Global Name Registry under this Agreement.

## **11. NO WARRANTIES BY GLOBAL NAME REGISTRY**

**THE PASSWORD AND THE DATA ARE PROVIDED "AS-IS." THE DATA IS PROVIDED WITHOUT ANY REPRESENTATIONS OR WARRANTIES AS TO ITS ACCURACY AND/OR COMPLETENESS. GLOBAL NAME REGISTRY DISCLAIMS ALL WARRANTIES WITH RESPECT TO THE PASSWORD AND THE DATA, EITHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NON-INFRINGEMENT OF THIRD PARTY RIGHTS. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF IMPLIED WARRANTIES OR THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATIONS OR EXCLUSIONS MAY NOT APPLY TO YOU.**

## **12. REFUSAL TO GRANT, RENEW PASSWORD**

To the extent permitted under the registry agreement by and between Global Name Registry and ICANN, Global Name Registry reserves the right to refuse to grant or renew a Password to you or to any of your Authorized Individual Users, and Global Name Registry shall not be liable to you or any of your Authorized Individual Users for any damages arising from Global Name Registry's refusal to sign this Agreement, issue a Password, grant access to the Data, or renew this Agreement upon re-certification.

### **13. NO CONSEQUENTIAL DAMAGES**

In no event shall Global Name Registry be liable to you or any of your Authorized Individual Users for any consequential, special, incidental or indirect damages of any kind arising out of the use of the Password or the Data or the termination of this Agreement, even if Global Name Registry has been advised of the possibility of such damages.

### **14. TERMINATION**

You may terminate this Agreement at any time by erasing the Password and providing written notice of your termination to Global Name Registry at 240 East India Dock House, East India Dock Road, London E14 9YY, UK.

Global Name Registry has the right to terminate this Agreement immediately if:

- (a) an ICANN-approved change in the method of access under the Agreement or any terms and conditions of the Agreement results in a failure of its essential purpose;
- (b) you or any of your Authorized Individual Users violate the terms and conditions of this Agreement; or
- (c) such termination is required by law, regulation, or a change in ICANN approved policy;
- (d) your continued access to and use of the Data or that of your Authorized Individual Users would cause Global Name Registry to be in violation of any applicable law or regulation;
- (e) Global Name Registry discovers that the user information provided in Section 2 above is inaccurate in any material way and such inaccuracy is not corrected within 48 hours of Global Name Registry's issuance of an e-mail to the e-mail address listed in Section 2(h).

### **15. RECORD RETENTION**

You agree that Global Name Registry may collect information about the number and type of searches conducted by you and your Authorized Individual Users including details about the search terms used and the result of such searches. Global Name Registry will not disclose such information except:

- (a) in aggregated form, from which you are not identifiable;
- (b) in response to requests from law enforcement or regulatory authorities;
- (c) as required by law or legal process including subpoenas; and
- (d) as necessary to protect the safety, legal rights, and property of Global Name Registry or any third party; provided, however that Global Name Registry will notify you via e-mail to the address listed in Section 2(h) above seven (7) days before disclosing information

under the exception set forth in this Subsection (d) unless Global Name Registry makes a good faith determination based on information available to it at the time and without any obligation to seek additional information, that such disclosure would pose a threat to the safety or property of Global Name Registry or any third party or would undermine Global Name Registry's or a third party's efforts to establish, assert or defend its legal rights.

#### **16. SEVERABILITY**

In the event of invalidity of any provision of this Agreement, the parties agree that such invalidity shall not affect the validity of the remaining provisions of this Agreement.

#### **17. GOVERNING LAW**

This Agreement shall be governed and construed in accordance with the laws of the England and Wales. You agree that any legal action or other legal proceeding relating to this Agreement or the enforcement of any provision of this Agreement shall be brought or otherwise commenced in London, England. You expressly and irrevocably agree and consent to the personal jurisdiction and venue of the courts located in the United Kingdom (and each appellate court located therein) for matters arising in connection with this Agreement or your obtaining, use, or distribution of the Data. The United Nations Convention on Contracts for the International Sale of Goods is specifically disclaimed.

#### **18. SURVIVAL**

The provisions of this Agreement will survive the termination or expiration of this Agreement for any reason with respect to Data you have accessed or acquired prior to such termination or expiration.

#### **19. ENTIRE AGREEMENT**

This is the entire agreement between you and Global Name Registry concerning use of the Password and access to and use of the Data, and it supersedes any prior agreements or understandings, whether written or oral, relating thereto.
