I, a sworn law enforcement officer, agree that I have not added any CJIS data in this report.

I, DEPUTY BRANDON SONN, WAS RESPONDING TO A DISTURBANCE IN SPRING GREEN, WI. I WAS IN THE AREA OF HWY 60 AT HWY B, WHEN I WAS FLAGGED DOWN BY A HISPANIC MALE. I ALSO OBSERVED A WHITE SUV SITTING IN THE DITCH AREA, WITH HEADLIGHTS POINTED UPWARD. THE SUV APPEARED TO BE IN THE SMALL CREEK ON THE SOUTHEAST SIDE OF THE ROADWAY. I CHECKED ON OCCUPANTS OF THE VEHICLE. WENDY J. JIMENEZ HERNANDEZ (FRONT PASSENGER), ANA S. SANCHEZ RODRIGUEZ (2ND ROW PASSENGER LEFT SIDE), AND EDWIN J. SANCHEZ RODRIGUEZ (2ND ROW PASSENGER RIGHT SIDE), ALL ADVISED THEY WERE OKAY AND DID NOT REQUEST AN AMBULANCE. I OBSERVED NO DRIVER IN THE VEHICLE. I SPOKE TO THE HISPANIC MALE WHO VERBALLY IDENTIFIED HIMSELF AS EDWIN A. SANCHEZ RODRIGUEZ (7/29/88). EDWIN A. STATED HE HAD PARKED THE VEHICLE ON THE SHOULDER FOR APPROXIMATELY 4-5 MINUTES WHILE TRYING TO HELP HIS FRIEND WHO HAD BROKEN DOWN IN A SEDAN, AND THAT VEHICLE WAS ON SCENE. EDWIN A. SAID THAT HIS VEHICLE BEGAN TO ROLL BACKWARDS WITHOUT HIM IN THE VEHICLE. EDWIN A. SAID HE WAS NOT OPERATING IT WHEN THIS HAPPENED. I DID NOT OBSERVE ANY SIGNS OF IMPAIRMENT. CRAIG'S TOWING WAS REQUESTED TO THE SCENE AND PULLED THE SUV OUT OF THE DITCH. THE VEHICLE APPEARED DRIVABLE, AND BY THE REQUEST OF EDWIN A., THE VEHICLE WAS DRIVEN FROM THE SCENE. CRAIG'S TOWING REMOVED THE UNRELATED DISABLED VEHICLE FROM THE ROADWAY. PHOTOGRAPHS OF THE SCENE WERE TAKEN, AND MY BODY WORN CAMERA WERE ACTIVATED FOR THIS INCIDENT. ALL PARTIES LEFT THE SCENE.
