Highway at Albert Street, Redditch, Worcestershire

The Secretary of State for the Environment, Transport and the Regions hereby gives notice that he has made an Order under section 247 of the above Act entitled "The Stopping-up of Highways (County of Hereford and Worcester) (No. 4) Order 1997", authorising the stopping-up of a length of highway at Albert Street, Redditch, Worcestershire, and requiring the provision of new highway shown as stippled on the deposited plan and the improvement of existing highway shown as cross hatched on the deposited plan.

The Order as made, will authorise the stopping-up only to enable the development described in the Schedule to this notice to be carried out in accordance with the planning permission granted by Redditch Borough Council on 29th April 1997, under Ref. 94/484,

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the above Act, or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of 29th October 1997, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
